- **Pool passes will be available for PICK-UP FROM THE MAIN STREET GREEN ON-SITE OFFICE BEGINNING MAY 17th IF THIS APPLICATION IS RECEIVED IN THE OFFICE BY MAY 6th. FOLLOWING MAY 6th, A \$10.00 ADMINISTRATIVE FEE WILL BE CHARGED, NO EXCEPTIONS WILL BE MADE.**
